Hopi Tribal Council approved the Hopi Tutuveni By-Laws as established and approved oversight by the Hopi Tutuveni Editorial Board. Operations and management of the one and only Hopi newspaper are supported via the H13 General Fund with supplemental funding coming from advertising revenues.

The Office Manager position with Hopi Tutuveni is currently vacant and we are seeking well qualified individuals who may be interested in working to inform, educate and provide a community service to the Hopi people.



# Hopi Tribe Department of Health and Human Services Covid-19 Emergency Response -Re-publication

**Kykotsmovi, Ariz. - June 2023** marks one year for the Hopi Tribe Department of Health and Human Services (DHHS) for occupancy of office space at the newly developed Turquoise Well Government complex. You may be asking yourself; "Where is the Turquoise Well government complex?" "What is the Turquoise Well Government complex?"

The Turquoise Well Government complex is the newly developed area on Hopi lands for Hopi Tribal offices which is located 15 miles northeast of the Hopi Cultural Center. The complex was developed in response to the COVID-19 Public Health Emergency for Tribal programs. DHHS Administration, Public Health Compliance and the Small Animal Control program have been working at the Turquoise Well complex since June 2022. In January 2023 the staff had to resort to teleworking due to mechanical failure of the generator which provides electrical power for day-to-day operations. DHHS Administration, Public Health Compliance and the Small Animal Control, are some of the programs affected however the staff of the programs continue to provide services, such as the recent Food Handler's class held in the village of Bacavi and the tick prevention event. Hopi Executive Order No. 002-2022 issued on March 3, 2022 continues to remain in place until such time the Hopi Tribal Leadership determines to lift the Executive Order. Data from the Hopi Health Care Center and surrounding health care facilities showcase a significant reduction in positive COVID-19 cases and data continues to be monitored and assessed.

Public Health Authority, Dr. Darren Vicenti, has been working in consultation with Tribal Leadership and local health centers in regards to COVID-19 cases and has determined that the number of positive cases remain low and will be defining next steps for data sharing.

Various sources of literature predicted that the COVID-19 virus will become endemic over time; what does that mean? An Endemic Disease means that the virus will continue to be present in a population or region with a relatively low spread OR there may be periods when it doesn't affect people at all.

The straightforward message to the community is to seek medical advice from your local medical provider for proper care and guidance to avoid further spread to family members if you feel symptoms. The recommended public health practice is to continue with proper hand hygiene, staying home when feeling ill and most importantly get vaccinated.

Hopi Executive Order No. 002-2022 language indicates the following:

1. It is recommended that everyone ages 5-years and older get a complete serious of the COVID-19 vaccine (mandatory for tribal government employees).

2. Face covering use shall be required inside all public facilities and buildings, and certain common areas. (lifted Hopi Executive Order No. 001-2023)

3. The Hopi Law Enforcement Services and health professionals, including community workers will coordinate with village leaders and village security officers to allow for welfare checks and other health-related contacts.

The Hopi Community Health Services (CHR) program continues to make available COVID-19 home test kits. Personal Protective Equipment (PPE) such as hand sanitizers, face masks and sanitary wipes are limited and will be issued if supplies are available. Come enjoy live music, delicious food, good company and a fun filled evening. All HSAPC events welcome volunteers, and are drug/substance free events. HSAPC mentors provide one to one mentoring services for youth and adults, group classes, community presentations, supportive programs for local schools, and cognitive restructuring for a positive recovery journey. 

# Statement of Priorities & Objectives October 1, 2023 – September 30, 2024

## **REQUEST FOR PUBLIC COMMENT**

Native American Disability Law Center (Law Center) is a non-profit organization that provides free legal services to Native Americans with disabilities. Every year the Law Center reviews its Statement of Objectives and Priorities to insure that we are best serving the needs of our client community. #### A - Intake & Outreach

Goal: Efficiently provide timely services to new clients & increase awareness of the Law Center's services through community & media-based outreach, providing training & information.

Objective 1: Access to Available Benefits. Assist seniors and individuals with disabilities receive appropriate services by helping them access programs that help pay for healthcare, food and energy, for which they are eligible.

Objective 2: Promoting Vocational Rehabilitation Services. Increase awareness of vocational rehabilitation services through:

a. developing public awareness program and materials; and

b. maintain relationships with vocational rehabilitation programs, transition specialists, and other service providers to ensure awareness of the Law Center's programs and services.

Objective 3: Promote Self-Advocacy & Understanding of Rights. The Law Center will participate in local, regional & national outreach events, conferences & training events to increase:

a. the understanding of Native Americans with disabilities & their families of their rights to services, supports, & employment;

- b. the ability of Native Americans with disabilities & their families to advocate for their needs & services;
- c. the understanding of the issues facing Native Americans with disabilities; &

d. awareness of the Law Center & its services.

### B - Children's Education & Safety

Goal: All Native American children in the Four Corners region will have access to appropriate education & services designed to keep them safe & meet their unique needs in the least restrictive environment.

Objective 1: Represent Abused and Neglected Children. Represent Native American children as Guardian Ad Litem or Youth Attorney in child abuse & neglect cases in New Mexico and the Navajo Nation through court appointments.

Objective 2: Promote Self-Advocacy. Provide technical assistance to families of twenty-five (25) students with disabilities to empower them to advocate for their children to obtain appropriate education and related services in the least restrictive environment in their community.

Objective 3: Direct Representation. Provide direct representation in meetings, informal settings, and/or administrative proceedings to twenty (20) children with disabilities who are not receiving a free appropriate public education in the least restrictive environment, with priority given to students who are facing exclusion-ary discipline or are otherwise excluded from school or who are not receiving appropriate transition services.

Objective 4: Systemic Advocacy. Through systemic advocacy, ensure that the federal & state education systems meet the educational needs of Native American students with disabilities enrolled in their schools by addressing the general education, special education, mental health, and wellness needs of students, including those impacted by trauma and adversity.

### **C** - Community Integration

Goal: Native Americans with disabilities will be free from abuse and neglect, whether they live in the community, residential facilities or correctional institutions, and receive appropriate supports & services to enable them to live in the most integrated, least restrictive settings appropriate to their choices and needs.

Objective 1: Monitoring Facilities and Services. Monitor facilities and institutions at least quarterly for instances of abuse and neglect, distributing educational materials, and providing advocacy services for individuals who are allegedly being abused or neglected.

Objective 2: Promote Community Access. Provide direct assistance to individuals with disabilities in their efforts to obtain appropriate community services, such as housing, voting, votational rehabilitation services or address employment discrimination.

Objective 3: Advocate for Improved Access to Public Buildings and Services.

Through systemic advocacy, increase access to public buildings and services for all individuals with disabilities.

# **Drug Dealer Who Distributed** Methamphetamine on Hopi Reservation Sentenced to Three Years in Prison

PHOENIX, Ariz. – August 31, 2023 Vanessa Rene Dundon (a.k.a. Sioux Z, a.k.a. Suzie Q), 38, of Indian Wells, Arizona, was sentenced last week by United States District Judge Diane J. Humetewa to three years in prison, followed by three years of supervised release. As a condition of her supervised release, Dundon cannot travel to, or be on, the Hopi Reservation. Dundon pleaded guilty to Possession with Intent to Distribute Methamphetamine.

"Drug trafficking causes particular harm for tribal communities," said United States Attorney Gary Restaino. "The exclusion of defendant from the Hopi Reservation is an additional tool to prevent future har

Dundon was stopped in her vehicle on the Hopi Reservation in April 2021, March 2022, and April 2022. On each occasion, she had controlled substances in her vehicle. At the change of plea hearing, Dundon admitted that on April 17, 2022, she possessed 58.4 grams of pure methamphetamine and that she intended to deliver it to other individuals in exchange for payment.

The Federal Bureau of Investigation, Phoenix Field Office, and Hopi Law Enforcement Services conducted the investigation in this case. The United States Attorney's Office, District of Arizona, Phoenix, handled the prosecution.



# Native Healing Coalition partners with Swarthmore and Haverford colleges to digitize records from Quaker-operated Indian boarding schools

Minneapolis, MN— August 23, 2023 The National Native American Boarding School Healing Coalition (NABS) will digitize 20,000 archival pages related to Quaker-operated Indian boarding schools. NABS was awarded a grant of \$124,311 from the National Historical Publications and Records Commission to work with Friends Historical Library of Swarthmore College and Quaker & Special Collections at Haverford College.

Documents related to Quaker-operated Indian boarding schools have been largely understudied, as they exist in scattered collections with limited access. NABS is making these important histories readily available to scholars and non-specialists alike by housing the digital records in a public database.

"We are grateful to Swarthmore and Haverford for their willingness to partner with us as we try to better understand this history," said Stephen R. Curley (Diné), Director of Digital Archives for NABS. "This partnership is unique and necessary, and we hope it creates more opportunities in the future. It is going to take all communities working together to reveal the truth about Indian boarding schools."

In fall 2023, NABS, Swarthmore, and Haverford will scan 20,000 pages of enrollment papers, financial information, correspondence, administrative records, and photographs. The records from Swarthmore and Haverford, ranging from 1852-1945, relate to at least nine Quaker-operated Indian boarding schools that were located in Indiana, Kansas, Nebraska, New York, Ohio, Oklahoma, and Pennsylvania.

Following the scanning process, a community information session will be held with Tribal communities to discuss the project findings. The project will also include the production of a video that shares oral histories from boarding school survivors, their families, and others.

In spring 2024, the 20,000 digitized records will be made publicly available on a database called the National Indian Boarding School Digital Archive (NIBSDA), which NABS will launch later this year.

"I hope this partnership opens the door for more discussion and understanding about religious institutions' role in the operation of Indian boarding schools," said Celia Caust-Ellenbogen, Associate Curator for Friends Historical Library of Swarthmore College. "These records can inform us about the conditions in which Native students lived, how Quaker institutions were financed through the federal government, and reveal the motivations behind U.S. assimilation policy design."

"The digitization of these collections will yield new research and narratives about the underexamined history of Quaker-operated Indian boarding schools," said Sarah Horowitz, Curator of Rare Books & Manuscripts and Head of Quaker & Special Collections at Haverford College. "These records reveal storied experiences and information that is too often absent from the public record, but that are increasingly sought by historians of Native American and American history."
