Governor Katie Hobbs Visits Hopi September 8, 2023

Kykotsmovi, Ariz. - September 8, 2023 The Hopi Tribal Council Chambers were set and ready for a historical visit from the Governor of Arizona Katie Hobbs. Hopi Chairman Nuvangyaoma confirmed the visit was the first of its kind by asking Chairman Herman G. Honanie if during his administration any such visits by a Governor occurred, to which Honanie, confirmed this was a first.

The Chambers were set up in a round table fashion with Chairman Nuvangyaoma, Governor Hobbs and Vice Chairman Andrews seated with the Hopi Tribal flag, U.S. flag and Arizona State flag directly behind them and Hopi Tribal Council Representatives seated in front of them.

In addition to the Governor reading points of concerns and priorities of her office, HTC Representatives presented her with gifts of Native American style jewelry, Hopi arts and crafts and gracious words of gratitude for coming to visit Hopi.

In addition to spending time at HTC Chambers, a tour of Orayvi was provided, which was followed by a delicious meal of Hopi dishes cooked and served by Raymond Namoki, Village of Sipaulovi Representative, Miss Hopi and their aids at the Sipaulovi Youth and Elderly Center just after Edith Silas, Miss Lori Piestewa Post 80, and her entourage performed a traditional Hopi dance for the Governor and her staff.

Hopi Domestic Violence staff met and shared some concerns with the Governor before the day ended with a meeting with the Hopi Land Commission and Water & Energy Committee at the Sipaulovi Village Administrative Office.

More about the Governor's visit will continue in the October 4, 2023 publication of the Hopi Tutuveni as images and content were inaccessible due to the September 13, 2023 electrical power outage experienced reservation wide and at Hopi Tutuveni offices, as well.











Hopi Chairman and Vice Chairman Call a Meeting with Telecom Providers and Community Stakeholders Regarding Call Connection Issues

Kykotsmovi, Ariz. – September 14, 2023 Hopi Law Enforcement Services (HLES), 911 dispatch on Hopi, Hopi Health Care Center, the Tribal Offices, and Hopi families continue to experience call connection issues (regardless of provider, both cellular and landline.)

Resolving this issue is a top priority, which is why Chairman Timothy L. Nuvangyaoma, Vice Chairman Craig Andrews, and Hopi Law Enforcement met with Hopi Telecommunications, Inc. (HTI) and Cellular One to discuss progress. In addition, community stakeholders including Indian Health Services and the Department of Public Safety were in attendance.

During the meeting, company leadership from Cellular One and HTI shared details regarding the extensive testing of their own networks over the past few months. Diagnostic actions included directing calls over different routes, ordering and implementing additional circuits, call testing, and call tracing. Neither provider was able to isolate the issue, therefore HTI and Cellular One joined forces to bring in JSI, a world class telecom consulting firm, to help escalate the diagnostic process.

Our team is working closely with HTI and JSI to investigate why call connections are not always getting through," said Judd Hinkle, Cellular One CEO. "We have served the Hopi people for 22 years and our dedication to this community remains unwavering. With the close cooperation of technicians from HTI and JSI we eagerly anticipate a resolution. JSI has the ability to run call tracing along the entire call route, which helps to isolate the interruption in the call connection. This could be critical to resolving this problem."

YOU CAN HELP: HTI General Manager Carroll Onsae said, "The safety of the Hopi people is a top priority and progress is being made. That said, I must emphasize that this call connection issue is NOT specific to customers of one particular carrier, and we encourage anyone encountering a difficulty with call connections to let their provider know right away and provide as many details as possible. Any insight you can provide could be instrumental in isolating and resolving this issue."

New Movie "Touch the Water" Seeks Community Screenings Holt Hamilton's Newest Film Featuring a Hopi Woman as Lead, Opens During Native American Heritage Month

Mesa, Ariz. — Sept 15, 2023 Holt Hamilton's newest feature film "Touch the Water", which opens in theatres on November 3rd, is seeking community screenings across Native Country to celebrate, recognize and honor Native American Heritage Month during the month of November.

"Getting an indie film into theatres is extremely difficult. It brings a great sense of accomplishment for me when we do, but my passion and real joy is taking my films personally to the people. Seeing the reactions to the film up close and personal with new friends, is the real payoff," stated filmmaker Holt Hamilton. Hamilton continued, "I love spending time with the community. Sharing a mini-film workshop, getting a tour of the rez, meeting as many people as possible and hopefully breaking some frybread with everyone when we screen the film is one of my greatest dreams in life!"

The movie is projected to open in 12 theatres across Arizona and New Mexico in November and then expand to others across North America. "We eventually will hit the streaming platforms, but for now, I'm in the theatrical market for the long haul. I plan to put this in over 500 theatres and draw attention that small indie films have a place on the screen next to major Hollywood blockbusters," shared Hamilton. He continued, "I still get excited to see a movie on the big screen. Makes me feel like a little child again."

The film, after numerous cancelled production dates due to the COVID-19 pandemic, was finally produced in June 2021. The story follows the fictional journey of an 80 old Native American woman named Daisy who, played by first-time actor Perci Ami who is of Hopi descent, searches for purpose and excitement in life despite her daughters attempts to put her in a home and take away her independence. The movie's timely theme of You Are Never Too Old To Dream seems appropriate for our current world situation.

"I met Holt Hamilton at a conference were he was showing his movie "More Than Frybread". He asked if I would try out for one of the parts. I knew I wouldn't get the part, I am not a actor." Perci Ami shared. She not only got the part, she became the star of the film. "Giving an old lady like me an opportunity to live and take a risk is one of the greatest gifts of trust and hope I've been given." Ami shared.

"Touch the Water" will be the sixth movie in Holt Hamilton's indigenous film collection. Their first movie 'Turquoise Rose', also starred first-time Native actors in leading roles. "We've been giving first-time actors opportunities with speaking roles and time on the big screen for two decades. This has been my mission since day one and this film continues that tradition."

HTI-FTHP Hopi Telecommunications Fiber to the Premise (FTTP) Project set to start

Keams Canyon, Ariz. - September 8, 2023 Keams Canyon Arizona is where Hylan West, Inc., will begin the construction Fiber to the Premise project across the Hopi Reservation ending in Hotevilla, the project to start September 18, 2023. This is a 14-month project that has fiber connecting to homes, schools, and other locations.

Construction will be in progress Monday through Friday with work hours set for 7:00 A.M. -6:00 P.M. (MST). No work will be done during weekends, holidays nor during inclement weather.

Carroll Onsae, HTI General Manager, states this project was awarded to Hylan West, Inc. the project consists of approximately 37.91 miles of aerial and buried construction throughout the communities from Keams Canyon to Hotevilla. Vehicle traffic from the contractor's work trucks and construction equipment can be expected along HTI's existing

copper line routes along highways and easements.

The second; Onsae says is awarded to Diversified Solutions, Inc., to install fiber optic service drops to approximately 651 residential/business locations across Hopi. Construction will install a new fiber service drop (aerial or buried) from a fiber pedestal or pole to a new network interface device on the side of the premise. Construction will commence in mid-October 2023.

The full project is expected to be completed in December 2024. Hopi Telecommunications, Inc. is happy to get the project started knowing the Hopi People have been patiently waiting for the availability of fiber optic connections. Hopi is a unique area and HTI wants to make sure all construction guidelines and protocols with local Villages and Communities are obtained for proper guidance and/ or consent in compliance with tribal ordinances and village traditional practices for a successful outcome.

Hopi Tribe Department of Health and Human Services Covid-19 Emergency Response -Re-publication

Kykotsmovi, Ariz. - June 2023 marks one year for the Hopi Tribe Department of Health and Human Services (DHHS) for occupancy of office space at the newly developed Turquoise Well Government complex. You may be asking yourself; "Where is the Turquoise Well government complex?" "What is the Turquoise Well Government complex?"

The Turquoise Well Government complex is the newly developed area on Hopi lands for Hopi Tribal offices which is located 15 miles northeast of the Hopi Cultural Center. The complex was developed in response to the COVID-19 Public Health Emergency for Tribal programs. DHHS Administration, Public Health Compliance and the Small Animal Control program have been working at the Turquoise Well complex since June 2022. In January 2023 the staff had to resort to teleworking due to mechanical failure of the generator which provides electrical power for day-to-day operations. DHHS Administration, Public Health Compliance and the Small Animal Control, are some of the programs affected however the staff of the programs continue to provide services, such as the recent Food Handler's class held in the village of Bacavi and the tick prevention event. Hopi Executive Order No. 002-2022 issued on March 3, 2022 continues to remain in place until such time the Hopi Tribal Leadership determines to lift the Executive Order. Data from the Hopi Health Care Center and surrounding health care facilities showcase a significant reduction in positive COVID-19 cases and data continues to be monitored and assessed.

Public Health Authority, Dr. Darren Vicenti, has been working in consultation with Tribal Leadership and local health centers in regards to COVID-19 cases and has determined that the number of positive cases remain low and will be defining next steps for data sharing.

Various sources of literature predicted that the COVID-19 virus will become endemic over time; what does that mean? An Endemic Disease means that the virus will continue to be present in a population or region with a relatively low spread OR there may be periods when it doesn't affect people at all.

The straightforward message to the community is to seek medical advice from your local medical provider for proper care and guidance to avoid further spread to family members if you feel symptoms. The recommended public health practice is to continue with proper hand hygiene, staying home when feeling ill and most importantly get vaccinated.

Hopi Executive Order No. 002-2022 language indicates the following:

1. It is recommended that everyone ages 5-years and older get a complete serious of the COVID-19 vaccine (mandatory for tribal government employees).

2. Face covering use shall be required inside all public facilities and buildings, and certain common areas. (lifted Hopi Executive Order No. 001-2023)

3. The Hopi Law Enforcement Services and health professionals, including community workers will coordinate with village leaders and village security officers to allow for welfare checks and other health-related contacts.

The Hopi Community Health Services (CHR) program continues to make available COVID-19 home test kits. Personal Protective Equipment (PPE) such as hand sanitizers, face masks and sanitary wipes are limited and will be issued if supplies are available. 



A - Intake & Outreach

Goal: Efficiently provide timely services to new clients & increase awareness of the Law Center's services through community & media-based outreach, providing training & information.

Objective 1: Access to Available Benefits. Assist seniors and individuals with disabilities receive appropriate services by helping them access programs that help pay for healthcare, food and energy, for which they are eligible.

Objective 2: Promoting Vocational Rehabilitation Services. Increase awareness of vocational rehabilitation services through:

a. developing public awareness program and materials; and

b. maintain relationships with vocational rehabilitation programs, transition specialists, and other service providers to ensure awareness of the Law Center's programs and services.

Objective 3: Promote Self-Advocacy & Understanding of Rights. The Law Center will participate in local, regional & national outreach events, conferences & training events to increase:

a. the understanding of Native Americans with disabilities & their families of their rights to services, supports, & employment;

- b. the ability of Native Americans with disabilities & their families to advocate for their needs & services;
- c. the understanding of the issues facing Native Americans with disabilities; &

d. awareness of the Law Center & its services.

B - Children's Education & Safety

Goal: All Native American children in the Four Corners region will have access to appropriate education & services designed to keep them safe & meet their unique needs in the least restrictive environment.

Objective 1: Represent Abused and Neglected Children. Represent Native American children as Guardian Ad Litem or Youth Attorney in child abuse & neglect cases in New Mexico and the Navajo Nation through court appointments.

Objective 2: Promote Self-Advocacy. Provide technical assistance to families of twenty-five (25) students with disabilities to empower them to advocate for their children to obtain appropriate education and related services in the least restrictive environment in their community.

Objective 3: Direct Representation. Provide direct representation in meetings, informal settings, and/or administrative proceedings to twenty (20) children with disabilities who are not receiving a free appropriate public education in the least restrictive environment, with priority given to students who are facing exclusion-ary discipline or are otherwise excluded from school or who are not receiving appropriate transition services.

Objective 4: Systemic Advocacy. Through systemic advocacy, ensure that the federal & state education systems meet the educational needs of Native American students with disabilities enrolled in their schools by addressing the general education, special education, mental health, and wellness needs of students, including those impacted by trauma and adversity.

C - Community Integration

Goal: Native Americans with disabilities will be free from abuse and neglect, whether they live in the community, residential facilities or correctional institutions, and receive appropriate supports & services to enable them to live in the most integrated, least restrictive settings appropriate to their choices and needs.

Objective 1: Monitoring Facilities and Services. Monitor facilities and institutions at least quarterly for instances of abuse and neglect, distributing educational materials, and providing advocacy services for individuals who are allegedly being abused or neglected.

Objective 2: Promote Community Access. Provide direct assistance to individuals with disabilities in their efforts to obtain appropriate community services, such as housing, voting, votational rehabilitation services or address employment discrimination.

Objective 3: Advocate for Improved Access to Public Buildings and Services.

Through systemic advocacy, increase access to public buildings and services for all individuals with disabilities.



The Next PACT Act Deadline: Health Care Enrollment for Arizona Veterans who deployed to Combat Zones FOR IMMEDIATE RELEASE Although this deadline is writ-

Prescott, Ariz. - September 5, 2023 Until 11:59 p.m. local time on September 30, 2023, Veterans who deployed to a combat zone, never enrolled in VA health care, and left active duty between September 11, 2001 and October 1, 2013 are eligible to enroll directly in VA health care. This special enrollment period gives Veterans who served in Iraq, Afghanistan, and other combat zones an opportunity to enroll directly in VA health care without first applying for VA benefits.

VA encourages all eligible Arizona Veterans to visit VA.gov/PACT or call 1-800-MYVA411 to learn more and sign up for VA health care before the deadline. Veterans who are enrolled in VA health care are proven to have better health outcomes than non-enrolled Veterans, and VA hospitals have dramatically outperformed non-VA hospitals in overall quality ratings and patient satisfaction ratings. Additionally, VA health care is often more affordable than non-VA health care for Veterans.

This special enrollment period is a part of the PACT Act, the largest expansion of VA health care and benefits in generations. Since President Biden signed the PACT Act into law on August 10, 2022, more than 344,000 Veterans have enrolled in VA health care and more than 4.2 million enrolled Veterans have been screened for toxic exposures. In Arizona alone, more than 22,000 Veterans have received PACT Act benefits and more than 8,300 Veterans have enrolled in VA care.

"Are you a Veteran who deployed to a combat zone but never enrolled in VA health care? If you left active duty between September 11, 2001, and October 1, 2013, you should sign up now," VA Secretary Denis McDonough said. "Even if you don't need this care now, you may need it in the future – and once you're in, you have access for life. But don't wait – the deadline is September 30 – so go to VA.gov/PACT and apply today."

Although this deadline is written into law for this specific group of Veterans, many other groups of Veterans are able to enroll directly in VA health care without first applying for VA benefits - including many Vietnam Veterans, Gulf War Veterans. Veterans who deployed to a combat zone and transitioned out of the service less than 10 years ago, and more. Veterans who do not meet any of the above criteria can often still access VA health care by filing for VA benefits or based on income. If a Veteran is granted service connection for any health condition, they become eligible for VA care.

The PACT Act also expanded VA benefits for millions of Veterans, making more than 300 health conditions "presumptive" for service connection. This means that if an eligible Veteran has one of these health conditions, VA automatically assumes that the condition was caused by the Veteran's service and provides compensation and care accordingly. Since the PACT Act was signed into law, VA has delivered more than \$1.85 billion in PACT Act benefits to Veterans and their survivors. VA encourages Veterans and their survivors to apply for these benefits now at VA.gov/PACT.

VA is currently in a full-court press to ensure that as many Veterans as possible enroll before September 30. To date, VA's PACT Act outreach campaign has included more than 2,000 events nationwide, \$13 million in paid media, 60,000 earned media clips, more than 400 million emails and letters to Veterans, the creation of a one-stop-shop PACT Act website, and more. This is the largest outreach campaign in VA history, which has one goal in mind: ensure that all Veterans – and their survivors – get the health care and benefits they deserve under the PACT Act.
